

**NHRCI RESCUE AN ORPHAN 12 YEARS OLD BOY IN UNCONSCIOUS CONDITION
FROM SONARPUR RAILWAY STATION AND AFTER TREATMENT SEND HIM TO
LAKHIKANTOPUR HASUS HOME**

An unidentified minor boy age approx 12 years found in Sonarpur Railway Station, Sonarpur, South 24 Parganas, West Bengal on last 4.6.2016 (Saturday) in an unconscious situation with a major head fracture lying for last few hours. He had found that his head had been first aid nominally with a bandage but still it's bleeding. The booking clerk of Sonarpur Railway Station Mrs. Kalpita Nath (Also Co-Convener, Sonarpur Of **National Human Rights Community of India**) shown her kind humanity and inform this issue through telephone to Mrs. Sabita Nath (West Bengal State Convener, South) & Mr. Saumen Das (General Secretary of **National Human Rights Community of India**) and request them to take needful action. Mr. Saumen Das (General Secretary of **NHRCI**) immediately convey this issue to Ms. Nayana Ghoshal (**Joint Secretary of Women Cell Child & Women Protection**) and ask her to take immediate action on this issue, Where as Mrs. Sabita Nath, she reached **Sonarpur Police Station** with Mrs. Swapna Mitra (District Convener, South 24 Parganas) & Mr. Aditya Ghosh (District Co-Convener, South 24 Parganas) and inform this issue to Mr. Sujoy Banerjee (Inspector- In-Charge of **Sonarpur Police Station**) as well as also inform to Mr. Tapajyoti Das (Officer-In-Charge of **Sonarpur GRP Station**). Immediately both the officers raised their hand to help the above mention Members of **NHRCI** to rescue that injured child. At first they took that child to the nearest hospital (**Subhashgram Government Hospital**) for a first-aid treatment where the on duty doctor investigate that child and bring him in sense where he was identified by his statement that his name is Amanulla Laskar, he is an orphan and he was begging for his daily needs in sonarpur railway station for last few months. The on duty doctor advice to shift him to **M.R.Bangur Hospital, Kolkata** for Head CT Scan. Approximately at 11.30 Pm the above mention Members Of **NHRCI** reached **M.R.Bangur Hospital, Kolkata**, talk to on duty Doctor and arrange to admit that injured child and next day Mrs. Sabita Nath & Mrs. Sapna Mitra contact to Local MLA Mr. Jibon Mukhopadhaya (Sonarpur South), and request him to arrange for a free treatment of that injured orphan child and he co-operate with them and immediately took needful action to do so. Ms. Nayana Ghoshal (**Joint Secretary of Women Cell Child & Women Protection**) & Mrs. Sabita Nath (West Bengal State Convener, South) of **NHRCI** request to the hospital authority and Superintendent of the hospital to keep the child in hospital for few days after his treatment until they arrange a proper stable life for that orphan child. On last 25.06.2016 the orphan child released from hospital & by joint co-operation of **NHRCI** & Superintendent of **M.R.Bangur Hospital** he had been send to **Lakhikantopur Hasus Home in South 24 Parganas** permanently. Their he is living a perfect life with good health. On last 5.6.2016 Ms. Nayana Ghoshal (**Joint Secretary of Women Cell Child & Women Protection**), Mr. Priyajit Khan (**Principal Secretary of NHRCI**), Mr. Saumen Das (**General Secretary of NHRCI**) & Mrs. Sabita Nath (**West Bengal State Convener, South**) visit **Lakhikantopur Hasus Home in South 24 Parganas** for a formal inspection.
